## **FLYING RATES & SERVICES**

(effective February 1, 2023; rates subject to change)

### **Helicopter Rates**

R-22 Training – solo* or dual	-	\$425/hr
R-44 Training – solo* or dual	-	\$675/hr
R-66 Training – solo* or dual	-	\$925/hr

\* - Solo rentals available on a case by case basis only; Restrictions apply

R-22 Photo & Other Flights	-	\$475/hr**
R-44 Photo & Other Flights	-	\$700/hr**
R-66 Photo & Other Flights	-	\$975/hr**

## Ferry Rates

(effective February 1, 2023; rates subject to change)

### Ferry Flights

These rates may be available on a case-by-case basis to log pilot/flight time in conjunction with an aircraft ferry flight.

R-22	- \$250/hr
R-44	- \$350/hr
R-66	- \$450/hr

- Must be PIC/Solo qualified in respective aircraft; if not PIC/Solo qualified then 5.0 hrs of dual in addition to ferry time may be required in respective aircraft.
- Customer transportation, lodging, meals, and personal expenses not included.
- Deposit or advance payment may be required on a case-by-case basis.
- If customer cannot complete the flight or cancels with less than 14 days notice, then customer will be billed at quoted hourly rate for any flying hours actually flown by the customer and may be billed at cost for any flying hours required to position the aircraft to the original/required destination (exceptions may apply and extenuating circumstances will be considered on a case-by-case basis).

### Aircraft Piloting/Ferrying Services

To pilot/ferry a customer's aircraft, HRH charges:

- \$850/day for up to 12 hour duty day\*
- \$85.00/hr over 12 hour duty day\*
- \* duty day begins 1 hour prior to scheduled takeoff & ends 30 mins after landing
- \$150/night charge for overnight trip
- Actual lodging & travel expenses reimbursement
- Fuel, oil, & trip related expenses reimbursement
